How to use the Reportable Income information posted on this page.

UK taxable investors who hold shares in a fund as at the last day of the fund's accounting period are required to look up the reportable income on this website and include it in their UK tax return.

The date this income is deemed to have been received by the investor is called the "fund distribution date" and is always six months after the fund's accounting year end. Thus, if the fund year end is 30 April 2017 (Imara Global Fund Limited 31 March 2017), investors holding shares at those dates should refer to this website for their reportable income information. This reportable income is deemed to be received on 31 October 2017 (Imara Global Fund Limited 30 September 2017), i.e. six months after the year end, and should be included in the investor's tax return for 2017/2018.
